# ABOUT THE FORUM

The International Forum on Attracting Investment to the Private Sector, Investing in the Future of Turkmenistan (IFT), is being held for the second time and has already established itself as an effective platform for direct dialogue between business, investors, and public authorities. The inaugural forum demonstrated strong international interest in Turkmenistan's investment opportunities and confirmed the practical, results-oriented nature of the format.

Last year, IFT 2025 brought together more than 500 participants from 25 countries, including representatives of over 40 international organisations, more than 180 foreign companies, over 180 local entrepreneurs, and representatives of more than 50 government institutions. The forum featured business meetings and negotiations in B2B and B2G formats, resulting in the signing of 21 framework agreements.


This year, IFT 2026 is expected to attract an even broader international audience, expand its business programme, and increase the number of concrete partnerships and investment arrangements.

## WHY IFT 2026?

IFT 2026 is a practical, results-driven business platform. Delegates gain direct access to partners and government bodies, opportunities for B2B and B2G meetings, as well as B2C contacts, as an international exhibition marking the 18th anniversary of the Union of Industrialists and Entrepreneurs of Turkmenistan will take place alongside the forum.

Participation also provides insight into the practical mechanisms for entering the Turkmen market and launching joint projects.

The forum brings business and government together to address specific objectives: partner search, market entry, structured dialogue with public authorities, and the formation of investment deals. IFT 2026 is the transition point from dialogue to real agreements.
